Executive Director's Letter

Advocacy Efforts for Hoosiers through COVID-19 crisis

On March 25th, we thanked Governor Holcomb for heeding our call to protect Hoosier renters from dangerous expansion on retaliatory evictions in SEA 148. The Governor recognized that the bill was "overly broad" and would have undermined the state's "numerous steps to protect Hoosiers from the spread and effects of COVID-19", including enacting an executive order pausing eviction and foreclosure from residential properties. That executive order is currently set to expire on May 5th, but Prosperity Indiana has recommended that Indiana take steps to go farther to protect Hoosier renters.

Earlier this month, Prosperity Indiana <u>submitted a letter</u> on behalf of our network opposing the federal government's proposed rule change that would undermine the CRA just as the COVD-19 crisis is causing PI members to shift much of their focus to the immediate needs brought about by the pandemic.

PI also joined state partners to <u>petition</u> the Indiana Supreme Court to protect CARES Act stimulus payments from being seized by creditors, arguing that "[g]arnishment of the stimulus funds threatens families' access to food, shelter, medicine and other necessities. These threats in turn will likely make the public health crisis even worse."

This week we were <u>awarded a grant</u> from the National Low Income Housing Coalition to conduct longer-term education and research and convene partners needed to achieve federal, state and local policies for an equitable response and recovery to the pandemic. We will be in touch with ways for members to be part of this ongoing advocacy effort.



Community Loan Center

Prosperity Indiana is the Indiana statewide coordinator for the Community Loan Center

(CLC), an affordable small-dollar loan program that serves as a payday-lending alternative. The CLC program allows local lenders to make online loans directly to employees of participating employers. Borrowers apply for a CLC loan online, the loan is deposited in the borrower's bank account, and borrowers then repay their loans each payday through payroll deduction. Twenty-three counties in Indiana are currently served by an Indiana-based CLC lender.

We're considering ways to expand this program in response to COVID-19. If you would like to see this program available in your community, please <u>reach out to us</u>.

Paycheck Protection Program

The <u>Paycheck Protection loan program</u> from the U.S. Small Business Administration (SBA) will help small businesses with their payroll and other business operating expenses. It will provide critical capital to businesses without collateral requirements, personal guarantees, or SBA fees – all with a 100% guarantee from SBA. All loan payments will be deferred for six months. Most importantly, the SBA will forgive the portion of the loan proceeds that are used to cover the first eight weeks of payroll costs, rent, utilities, and mortgage interest.

Central Indiana Community Foundation Response

CICF and its affiliates have adopted a four-pronged approach to the COVID-19 pandemic in Central Indiana to ensure that the health, economic stability, and service to the most vulnerable communities are being met during this crisis. Among its actions are to create two flexible funds, one for Marion County – the Neighbor Relief Fund for Marion County – and one for Hamilton County – Hamilton County Crisis Response Fund. IHCDA's Hardest Hit Fund Announced

IHCDA has re-instituted the mortgage payment assistance program through <u>Indiana's Hardest Hit Fund (HHF)</u>. The federally funded program allows them to provide up to 6 months of assistance or \$30,000 for Indiana homeowners struggling to pay their mortgage. <u>Apply online here.</u>

IHCDA has also worked with partners (Indiana Department of Financial Institutions, Indiana Apartment Association, Indiana Bankers Association, Indiana Mortgage Bankers Association, and Indiana Credit Union League) to compile a Coronavirus Eviction and Foreclosure Guide for homeowners and renters.

COVID-19 Federal Rural Resource Guide

USDA and its Federal partners have programs that can be used to provide immediate and long-term assistance to rural communities affected by the COVID-19 outbreak. These programs can support recovery efforts for rural residents, businesses and communities through:

- · technical, training, and management assistance
- financial assistance
- state and local assistance

The resource matrix organizes funding opportunities identified in the CARES Act and other federal resources that can help support rural America. Opportunities are categorized by customer and assistance type.

The Unequal Impact of the COVID-19 Crisis on Households' Financial Stability

Prosperity Now's <u>new Scorecard brief</u> discusses the disproportionate effects that COVID-19 will have on the finances of families and individuals who were facing economic uncertainty even before the virus began to take aim at the U.S. economy.

According to the organization, the brief "describes a tale of two kinds of communities – one that will be greatly impacted by COVID-19, but stands to recover; and one that will face economic devastation if we don't take immediate policy action."

New Tool for Non-Filers and Economic Impact Payments

To help millions of people, the Treasury Department and the Internal Revenue Service launched a <u>new web tool</u> allowing quick registration for Economic Impact Payments for those who don't normally file a tax return.

The non-filer tool, developed in partnership between the IRS and the Free File Alliance, provides a free and easy option designed for people who don't have a return filing obligation, including those with too little income to file. The feature is available only on IRS.gov.

Eligible taxpayers who filed tax returns for 2019 or 2018 will receive the payments automatically. Automatic payments will also go in the near future to those people receiving Social Security retirement, survivors, disability (SDDI), or survivor benefits and Railroad Retirement benefits.

AARP Community Challenge Application Deadline Extended

AARP invites your organization to submit applications for quick-action projects that can help your community become more livable for people of all ages.

Eligible applications for the AARP Community Challenge are being accepted for small grants to improve housing, transportation, public space, technology, civic engagement, and more.

The application deadline has been extended to May 15, 2020, 11:59 p.m. ET, and all projects must be completed by December 18, 2020.

General Information & Precautions

- -Wash your hands for 20 seconds.
- -Clean and disinfect frequently touched surfaces daily.
- -Avoid touching your face.
- -Encourage teleworking when feasible.
- -Practice social distancing when possible and avoid close contact with others. This may include staggering work schedules, decreasing social contact in the workplace, and avoiding large work-related gatherings.

Decisions about the implementation of community measures will be made by local and state officials, in consultation with federal officials as appropriate, and based on the scope of the outbreak and the severity of illness. Implementation will require extensive community engagement with ongoing and transparent public health communications (CDC).

Until May 4, 2020, our team will primarily be working remotely. We will reassess this return date, in light of available information and any stay at home orders related to COVID-19, and will provide updated information to member regarding any changes.

Governor's Recent Executive Order

Governor Eric J. Holcomb issued a new two-week Stay At Home order designed to limit interactions among Hoosiers to increase containment of COVID-19 on April 6.

"Hoosiers have done a great job adapting to the new rules put in place during this public health emergency, but I believe the next two weeks to month could be the most critical for all of us," said Gov. Holcomb. "So I am asking you to take even more precautions: only make in-person purchases when absolutely needed and use other delivery and pickup options when available. Limit who is traveling with you and entering stores."
