## **Executive Director's Letter**

"Hunky gunky fall ... All done." <u>Translation (of my almost two-year-old's words)</u>: Humpty Dumpty had a great fall ... All done." (But I'm guessing you got that last part.)

And somehow, I think my daughter's inability to fully express that story – and just quitting on her recitation of it when it got too hard – can relate a lot to our work these days. In fact, communication and the alphabet – the letter P – (and putting a broken Humpty Dumpty back together again) are all unofficial themes of my letter today.



Hard stop.

"Small P" policy. I've heard that phrase FAR more than usual of late. And I think part of that is – PI is KNOWN for "Big P" policy, and people want to distinguish what we're known for with what else they need us to do. For instance, we know how to glean challenges and solutions from the field and convert that into legislation. We know how to gain consensus. We know how to craft an agenda. We know how to find bill sponsors. And frankly, we know how to get our issues into the news. BUT, to be clear, we also absolutely KNOW that not all work is done within the "halls" of the Statehouse or on Capitol Hill.

For one, even big P policy is often done best on legislators' home turf. And that is exactly why we traveled around the state to six different locations during the unexpected COVID surge that was the month of August (dodged some bullets there). Somehow legislators hear better when your voices aren't crowded out by people who don't do what you do every day. And for those who attended those meetings, thank you! YOU provided the hook to get legislators there, and YOUR EXPERTISE – and local perspective – make all the difference in those conversations.

And I'll be the first to admit: It's one thing for us to espouse data and our analysis of it. It's absolutely next-level critical for you to back it up with stories from what you're seeing day to day.

But we absolutely hear you that not every challenge can or should be handled with a bill number attached.

Some of what we heard was that those holding the purse strings make your job far too hard; and, as a result, despite all of the additional resources available, it's easier said than done to shift from a mindset of scarcity to a mindset of abundance – even now. Some of you indicated that you've been provided with just enough resources to survive and do more to meet current demand, but not enough to really thrive and set yourself up for future success. Some talked about the administrative burdens attached to programs that are making you think twice about considering them an option in the future. And some of you are so overwhelmed with meeting the additional needs of the moment, you don't have capacity to fight your way into a seat at the table to change these dynamics going forward.

#### We hear you.

We also heard that, for those of you who were brave enough to expand your team during COVID to meet the demands of the day, you're not doing it without recognition that you're not sure what life post-COVID funding looks like and when that will be – whether a year or two or three down the line. And you need a community development infrastructure that understands that challenge and is committed to setting you up for success after you've helped deploy additional resources, and not just exploit your expanded capacity while it's needed by others to spend down funds.

#### We hear you.

And we are hearing that you need additional resources – not just dollars – but information and training and people and tools. And you need the vernacular around your work and describing the people you serve to change. And you need systems to work differently.

And that's all *technically* "small P" stuff. But if those things changed, wouldn't the impact feel BIG?!

So, please, by all means, complete the policy survey we'll be sending out next week. But please, don't let that be the last time we hear from you until "Policy & Pizza" or our Summit or regional meetings, etc.

Keep helping us help you by giving voice to the challenges and solutions you face – like those you shared during our regional meetings. But please keep us posted on the "small P" policies and systems that impact your work, and how, by collaborating with others, we can bring about change.

And maybe, just maybe, if we all become even better connected to each other's work on the ground and work together a little differently on small P stuff – and if someone other than the king's men played a role in putting Humpty back together again – we just might have a different outcome before we announce "All Done." So, please – as you think of things – <u>keep sharing</u> the myriad of ways that we can be helping you. No idea is too big or too small.

And thank you, as always, for being a Piece of the PI Network.

#### **Creating a Land Bank Movement**

Tarik Abdelazim, a national expert on land banks with the Center for Community Progress, spoke with more than 60 community leaders in South Bend regarding best practices within the land bank movement. Many Indiana communities struggle with vacant, abandoned, and deteriorated properties. Land banks are quasi-public entities that take temporary ownership of delinquent properties and, in a transparent and consistent manner, transfer them to responsible buyers who will repurpose them into productive uses consistent with community priorities. The August 30th meeting, co-sponsored by PI and eight other South Bend community-based organizations, leveraged Tarik's and CCP's extensive experience to outline how a land bank could work in and benefit South Bend. The meeting was part of CCP's technical assistance scholarship to PI and a value-add to PI membership.
